The Executive Committee performs the following duties:

- Fixes the policy of the Museum subject to the affirmative approval of the Board.
- Examines the Museum's monthly financial reports.
- Develops a strategic plan for recruitment of candidates for Board membership and for the development of at-large Board members after identifying and considering demographic and skill area gaps in relationship to the Museum's current and strategic needs.
- Recommends potential candidates to the Board for consideration for appointment as at-large Board members.

The Executive Committee meets monthly as needed or as often as necessary to dispatch pertinent business on call of the Chair or by request of any three Committee members. Minutes of each meeting of the Executive Committee are presented to the Board at its first meeting following such Executive Committee meeting.

Nine of the Museum's Directors are appointed by the Executive Board of the Harris County Medical Society. Baylor College of Medicine, University of Texas Medical School, and the Houston Independent School District each appoint one Director.
